# Kybella® (Non-invasive fat reduction)

## **IMPORTANT**

- Please alert us of any medical conditions you may have and/or any prescribed medications you are taking prior to your treatment.
- Treatment is not recommended if you are pregnant, nursing, taking blood thinners or immunosuppressants, or are immunocompromised.
- Results can vary from person to person.

#### **Pre-Kybella® Instructions:**

- The ideal time to schedule this procedure is at LEAST 2 weeks before a big event.
- Inform us if you have a history of DIFFICULTY SWALLOWING, medication allergies, history of anaphylaxis, and any other medical problems.
- Take ibuprofen, Motrin or Advil about 1 hour before your appointment.

#### Post-Kybella® Instructions:

- After the treatment, ice the areas treated with Kybella® gently for a few times that day.
- Treated areas may be red, inflamed, swollen and bruised for the first 2-7 days.
- If bruising occurs, apply topical Arnica gel to help bruising resolve faster. We also have a laser to help speed up the recovery time and makeup to help conceal it if necessary. Please call us when it's needed.
- A scarf is recommended if area is swollen.
- All normal activities including exercise can be resumed as long as it is comfortable for you.
- Take Ibuprofen, Motrin or Advil or apply cold compression if needed for discomfort after the treatment.
- Kybella®requires 2-4 sessions for optimal treatment. Remember to schedule your next appointment in 6-8 weeks.
