In consideration for being permitted to utilize any and all Services and Treatments at Mill Creek Skin & Laser Center, I, on behalf of myself and any minor child/children for whom I have the capacity to contract, hereby acknowledge and agree to the following:

- 1. I, the undersigned, understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention ("CDC") guidelines regarding COVID-19. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC guidelines are regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent updates.
- Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to utilize the Services and Treatments at Mill Creek Skin & Laser Center.
- 3. I hereby agree, represent and warrant that I shall not visit or utilize the Services and Treatments at Mill Creek Skin & Laser if I (i) experience symptoms of COVID-19, including, without limitation, fever, cough or shortness of breath, or (ii) have a suspected or diagnosed case of COVID-19. I agree to notify Mill Creek Skin & Laser immediately if I believe that any of the foregoing access/use restrictions may apply.
- 4. In accordance with the most recent guidance and protocols issued by the World Health Organization ("WHO"), the Centers for Disease Control and Prevention ("CDC") and the Washington State

 Department of Health ("DOH"), for slowing the transmission of COVID-19, I hereby agree, represent and warrant that I shall not visit or utilize the services and treatments at Mill Creek Skin & Laser within 14 days after (i) returning from highly impacted areas subject to a CDC Level 3 Travel Health Notice, (ii) exposure to any person returning from areas subject to a CBC Level 3 Travel Health Notice, or (iii) exposure to any person who has a suspected or confirmed case of COVID-19.
- 5. Mill Creek Skin & Laser has taken certain steps to implement recommended guidance and protocols issued by the CDC and Public Health Agencies for slowing the transmission of COVID-19, including, without limitation, the access/use restrictions set forth above. I acknowledge and agree that Mill Creek Skin & Laser may revise its procedures at any time based on updated recommended guidance and protocols issued by the CDC and Public Health Agencies, and further agree to comply with Mill Creek Skin & Lasers revised procedures prior to utilizing the Services and Treatments at Mill Creek Skin & Laser.
